DESCRIPTION OF BUILDING PRODUCT

The Mammoth Acoustic Blanket and Acoustic Wall Sections are manufactured in NZ from recycled plastic bottles. The manufacture of the semi rigid acoustic wall sections uses up to 15,600 bottles/100 m² product while the acoustic blanket uses up to 4,300/100 m² product.

The blanket and wall sections will contribute to acoustic performance when the performance is calculated using the Mammoth acoustic performance software or specifically designed by an acoustic engineer. The acoustic blanket will also improve thermal efficiency where an R-value is stated. Although all products will improve thermal performance, unless an R-value is stated the extent of improvement is not quantified.

Mammoth Acoustic Blanket and Acoustic Wall Sections achieve a material group number IS when tested by [BRANZ](#) to ISO 9705.

BRANZ Appraisal 797 [2020] references products that are also listed as acoustic wall sections. The stated R-value for these products has been established through this appraisal.

The R-value claimed by Mammoth for the acoustic blanket and acoustic wall sections not referenced in the BRANZ appraisal has been derived using the same methodology as that relied upon by BRANZ including a test to NZS 4859.1 carried out by BRANZ.
